Notice

It has been observed by this Department that:-

- A) A considerable number of candidates who have qualified through NEET UG 2017 and have paid online for pre counseling process for West Bengal State quota and Private Management Quota counseling 2017 have failed to participate in document verification for various reasons and thereby have not been included in the State eligible list and thus have not been able to register after payment online to fill choices.

It has also been observed that:-

- B) Some candidates whose names appeared in the eligible candidate list of West Bengal have failed to register online and thereby failed to fill up choices.

On humanitarian ground, both these groups are provided a second chance for participation in round 2 of online counseling process for allotment to West Bengal State Quota and Private Management Quota seats 2017.

For candidates of Group A:-

The candidates who after online payment have failed to verify are allowed to appear for online verification at RG Kar Medical College Kolkata Platinum Jubilee Building auditorium on 7th and 8th August 2017 from 10 am till 4 pm as per server time.

Candidates if successfully verified will be entered in Updated Merit list under "Updated Eligible candidate list for State Quota and Private Management Quota" and will be allowed to register online. Such list will be published at 6 pm of 8th August 2017.

The time of such candidates to register online is between 10 am of 16th August 2017 till 11 am of 18th August 2017 as per server time.

If the candidates who appear for verification are rejected online due to issue of caste or domicile (and not due to invalidity on the ground of age of eligibility or below the required percentile marks in NEET UG 2017 or below the required percentage marks in 10+2 mark sheet) then they will appear in the updated eligible list for Private Management Quota only.

Such list will be published at 6 pm of 8th August 2017.


The time of such candidates to register online is between 10 am of 16th August 2017 till 11 am of 18th August 2017 as per server time.

For candidates of group B:-

Such candidates who were in the merit list earlier but failed to register in round 1 are not required to verify again. They can directly go for online registration during the time frame of 10 am of 16th August 2017 till 11 am of 18th August 2017 as per server time.

For both group A and B the period of choice filling and locking will remain unchanged as for all other previously registered candidates as was published in the revised schedule dated 10.07.2017 in the website www.wbmcc.nic.in
